WARRANTY CERTIFICATE

Warranty To The Customer

Undertakes, solely on his own behalf, to warrant the machine specified in the Warranty Certificate and supplied by Yanmar Construction Equipment International AB to be free from defects in material and workmanship for a period of **48 month/4000 hours** whichever occurs first, from the delivery date stated in this Warranty Certificate.

The Warranty implies that TDX Ltd undertakes to replace or repair any part or component acknowledged by TDX Ltd to be defective in material or workmanship according to the regulations between Yanmar Construction Equipment and TDX Ltd.

The warranty is not valid for defects on the machine if it has been involved in an accident, rebuilt or modified unless it is clear that such defects are not a result of such an accident.

The warranty period is not extended due to any stand-still caused by replacement examination or repair of the parts in question. The

Warranty does not apply to normal wear.

TDX Ltd is under no circumstances responsible for any personal injury, material damage, other direct or indirect damage or expenses or loss of profit in connection with a case of warranty.

The Warranty is only valid on condition:

- That the machine owner/driver has followed the recommendations as set out in the Operators Instruction Manual.
- That the machine has been used for the purpose for which it was intended.
- That the machine is maintained according to the manufacturer's Inspection and Maintenance Instruction and genuine YANMAR filters are used.
- That the anti-tamper seals, e.g.: on engines, hydraulics, electronics etc. are not broken by unauthorised persons and that the machine is not overloaded.
- That defects are not caused by the use of parts, which are not of Yanmar Construction Equipment's make.
- That defects are not caused by the use of oils, greases or coolants, which are not specified by Yanmar Construction Equipment.
- That defects are not due to the inadequate service modifications, replacement and/or repairs of the machine by a company other than an authorised TDX Ltd workshop.
- That the owner/driver has taken immediate action to prevent consequential damage in the event of the machine warning/indicator lamps being activated or other faults have been observed.

Exclusions:

- Wear parts i.e.: brakes, tyres, tracks, ground engaging tools, fuses, light bulbs, safety belts, cabin glass, options not supplied by Yanmar Construction Equipment and any subsequent damage due to misuse or abuse.

We accept no responsibility or compensation liabilities other than above. Consequently, the warranty disclaims any responsibility for direct or indirect losses or damages which may result from faulty material or workmanship.
